### **Dates and Time:**

The workshop will be held on Tuesday, March 15th at Sessions Woods Wildlife Management Area In Burlington, CT. The workshop will run from 8:00 am to 3:00 pm.

### **Registration Costs:**

Attendees coming from the Waterbury area can take Route 8 north to Thomaston and then Route 6 East until Route 69.

Attendees from Torrington can take Route 4 East until Route 69.

Attendees from New Haven can take I-91 north to I-691 West, and then I-84 East until Route 229. Route 229 leads to Route 6, which can be followed West until it crosses Route 69.
