The History of the CTPA

In 1919, due largely to the efforts of tree workers, Connecticut passed the "Tree Expert Law". This law established the licensing of tree experts and was the forerunner of today's Arborist Law. With the passage of the law, the state's tree care professionals saw the need for an organization that would promote the same values that the law sought to protect. Thus, on August 16, 1922, at Hammonasset State Park, the Connecticut Tree Protective Association was founded. The CTPA is the oldest association of its kind in the US.

CTPA came into being with 32 original members. By the following year, the membership had doubled in size, and the first officers were elected. Cornelius A. Millane served as the first President of CTPA, with Francis A. Bartlett as Vice-President and Walter O. Filley as Secretary-Treasurer. The newsletter began publication in 1946. In 1955, the CTPA was incorporated as a non-profit association. The CTPA has been active on many issues over the years. As a staunch defender of the integrity of the arborist license, CTPA opposed a proposal to revoke the Arborist Law in 1983 and an effort to split the license for line clearing personnel in 1991. CTPA also stood up for the Connecticut Agricultural Experiment Station when it faced budgetary uncertainty in 1996. More recently, CTPA was instrumental in the movement of the administration of the Arborist License to the Department of Energy and Environmental Protection.

CTPA remains dedicated to the principles of its founding. Today, membership in CTPA numbers over 800 individuals, from all ranks of those involved in tree care. Meetings of the CTPA regularly draw over 700 attendees, testimony to CTPA's role as an educational leader as well as a potent voice for those concerned about Connecticut's trees.

Membership

CTPA draws its members from throughout the ranks of those involved in the care and protection of Connecticut's trees. Applications for membership are presented to the Board of Directors, which votes on whether to accept each applicant. One year's dues must accompany each application for membership.

Regular Members

Regular members are individuals or representatives of firms engaged in arboriculture, urban forestry, landscape forestry or landscape gardening; individuals engaged in research, arboricultural education or related educational activities; tree wardens; or others engaged in non-commercial activities relating to the planting or protection of trees. Regular members in good standing are voting members.

Special membership rates are offered to two groups of regular members. Dues for regular members who are 65 years of age or older are \$25 per year. Initial dues for students currently enrolled in CTPA's Arboriculture 101 course are also \$25 per year.
