
Arboriculture 101 Spring 2010

Why you need to know about using pesticides for the care of trees... Sec 22a-54. Pesticide applicators...(h) The commissioner shall prescribe standards for certification of arborists, as defined in subsection (a) of section 23-61a, with respect to the application of pesticides. The standards shall provide that in order to be certified, an individual shall be competent with respect to the use and handling of the pesticide or class of pesticides covered by such individual's application..."

- "Certified" applicator
 - **"Commercial"** applicator

Bear in mind:
"Shall" means a mandatory requirement

Chapter 451-includes the arborist statutes

What is "arboriculture"?

Sec 23-61a. Definitions...(a) As used in sections 23-61a to 23-61f, inclusive, "**arboriculture**" <u>means any work done for hire to improve the</u> <u>condition of fruit, shade or ornamental trees</u> by feeding or fertilizing, or by pruning, trimming, bracing, treating cavities or other methods of improving tree conditions, or protecting trees from damage from insects or diseases or curing these conditions by spraying or any other method;..."







"..one who is qualified to perform arboriculture and is licensed by the Commissioner of Environmental Protection as provided in section 23-61b..."

The General Statutes simply state that it is unlawful to practice arboriculture without a license Sec. 23-61b. Licensing for arboriculture...(a) No person shall advertise, solicit or contract to do arboriculture within this state at any time without a license issued in accordance with the provisions of this section, except that any person may improve or protect any tree on his own premises or on the property of his employer..."

Arborist regulations

Arborist regulations

Sec. 23-61a-3. Licenses. "(b) For each organization there shall be at least one licensed person actively engaged in supervisory duties for each ten unlicensed personnel actively engaged in arboriculture."

Arborist regulations

- Sec. 23-61a-3. Licenses.
- "(c) <u>No licensee shall be designated to be</u> <u>licensed on behalf of more than one</u> <u>organization engaged in arboriculture at</u> any time."

Chapter 441- the Pesticide Control Act

...and related regulations

There are two classifications for commercial pesticide applicators..

Supervisory (the supervisor)

Operational (the operator)

What classification is the arborist?

Supervisor (Arborist)

- Duties Records
 - Written instructions



- What are the DUTIES of the supervisory (*arborist*) pesticide applicator?
- Makes decisions about pesticide use
- Keeps records of pesticide use and supervision
- May perform commercial pesticide applications
- Supervises operator (on site or with written instructions)
 - Submits annual pesticide-use summary

What RECORDS must a Supervisory pesticide applicator keep?

- He/she must keep records for each application of a pesticide. The record includes five points:
 - 1. Names and certification numbers of supervisor and operator(s)
 - 2. Kind and amount of pesticide used
 - 3. Date and place of application
 - 4. Pest treated for
 - 5. Crop or site treated
 - Also must submit annual summary to DEP

If WRITTEN INSTRUCTIONS to operators are used, what points need to be included? Written instructions include five points... 1. Certified supervisor's name and certification number, operator's name and certification number 2. Pest to be controlled 3. Pesticide to be used 4. Directions for use of the pesticide 5. Be available if and when needed

Under "written instructions," <u>directions</u> for use means...

- Place to use the pesticide
- Directions for dilution-rate to mix at, rate to use at
- Site or crop to treat
- Method of application to employ

The OPERATOR licensed pesticide applicator works under the supervision of the Supervisor (arborist)

- ✓ Operator Duties...
 - Only works under supervision, with the supervisor at the site of pesticide application or by written instructions
- Can read a pesticide label, and follow written instructions provided by supervisor
- Assists with or may perform pesticide applications. (A hose dragger, traffic flagger or helping to mix pesticides are examples.)

What are the three main requirements for pesticide application businesses?
1. Business registration
2. Business records
3. Notification

1. What is the BUSINESS REGISTRATION?

Certificate of registration
 At least one supervisor in each pesticide category(Arborist)



1-year, renewable registration (Sept1-Aug31)
 Report changes to DEP in writing within 30 days
 "B" number (assigned Business Number)

- 2. What RECORDS need to be maintained by the pesticide application business?
- Keep the five point pesticide application record for five years.
- Must have names and EPA Reg. Numbers of pesticides used by business on file.
- Must maintain names and certification numbers of all commercial applicators employed.

3. BUSINESS NOTIFICATION .as easy as A,B,C Vhat types of notification must be made to A. customers **B.** abutters C. the general public... concerning pesticide applications?

Notification Requirements

- A. Potential <u>Customer</u> information
 B. Notice to persons (<u>abutter</u>) listed on the Pre-Notification Registry
- C. Posting

A. What information must be supplied to a **Potential CUSTOMER**?

- This information must be given before entering into an agreement to apply pesticides to a customer's property.
- 1. Provide information describing what the pre-notification registry is.
- 2. Provide pesticide label information to the potential customer.

B. What is Connecticut's PRE-NOTIFICATION REGISTRY?

- The official list
- An abutter is on the official list or may become a pre-notification abutter mid-year.
- ✓ 24 hour notice

Continued...

- B. How do you provide PRE-NOTIFICATION to an abutter?
 - Make two attempts by any means.
 Place a notice on their door if all attempts fail and you must do the pesticide application.
 - Keep a record of your notification attempts.

C. How do you POST a pesticide application?

- The pesticide posting sign has specified requirements.
- The applicator posts the sign
- ✓ 12" to 48" high, 2 to 5 feet from the road entrance/sidewalk
 - Located at points of entry and every 150 feet of road frontage.

Regulations of Connecticut State Agencies...

pertaining to the use of pesticides by arborists

Pertinent pesticide regulations 22a-65-1 discarding of pesticides and containers 2a-66-2 pesticides not registered and use prohibited-DDT, Chlordane pesticides CT registered, but only for specific uses--Lindane

- Pertinent pesticide regulations 22a-66-3
- Must have check valve or anti-siphoning device on filler hose.
- Must cover filler hoses when not in use.
- Must not draw water from water leading into a potable water supply.

Pertinent pesticide regulations 22a-66-5 provides details of the following: Supervisory responsibilities **Operator responsibilities** Written instructions to operators 22a-66a-1 Requirements for posting 22a-66a-2 Pre-notification details34
