### **EXHIBIT SPACE INFORMATION**

**Tent Exhibit Space**: In the tent, exhibit space is a 10' x 10' area, located under a large, open sided tent. One 3 x 8 foot table is provided for each space. Electricity and additional tables can be ordered at the time of registration. The cost per exhibit space is \$275, with electricity and additional tables for an additional charge.

Because the tent is on a lawn, large or heavy equipment <u>cannot</u> be allowed into the tent. If you wish to display such equipment, we request that you rent space in the outdoor exhibit area.

**Outdoor Exhibit Space**: We offer exhibitors the opportunity to display their equipment in the outdoor exhibit area. Each outdoor exhibit space is 600 sq. ft. The cost of outdoor space is \$385 for the first space and \$165 for each additional space.


Exhibitors are encouraged to be creative in their use of exhibit space. Contact the CTPA office regarding any questions you might have.
