Tree Infection and Wood Decay Following Storm Injury. by Dr. Kevin Smith, USDA Forest Service, Durham, New Hampshire.

Dr. Smith will talk about how decay fungi are opportunists that take advantage of tree injury to infect and spread. This presentation will explore how trees respond to storm injury to compartmentalize the loss of functioning tissue and the spread of infection.

The Legacy of the Oklahoma City Survivor Tree. by Mark Bays, Oklahoma State Urban Forestry Coordinator, Oklahoma City, OK.

On April 19, 1995, one of the worst domestic terrorist attacks occurred in Oklahoma City. An American Elm in the heart of the city survived the attack. Mr. Bays will share the inspiring story of the Survivor Tree and the effort and planning it took to save and nurture this tree for the past 24 years. This project has been a challenge to him as a forester, arborist, citizen and public official throughout those years. As this site became a memorial, the project evolved into something more than simply caring for the tree.

Arboriculture Below Ground. by Aaron Dickinson, Arborology, LLC, Apple Valley, MN

In the urban environment, trees and shrubs typically grow in soils that are nutrient poor, lack natural soil biology and are likely compacted. This presentation explores the possibility of changing the paradigm from fertilization in the urban environment to restoring the natural process of decomposition and soil biology to our landscape trees for creating a healthy soil for trees to grow.
