8:45 Brian Fain, Ferguson & McQuire -Competing with Non-Compliant Operators. 9:00 **Restoring Pitch Pine in Connecticut.** Mr. Gluck will talk about Pitch Pine that was once a common tree in much of Connecticut and now, one of Connecticut's thirteen imperiled ecosystems with an estimated loss of over 95% of its area. Trees are being lost at an alarming rate and they are not adequately sustaining new generations under current natural conditions especially with the expansion of the Southern Pine Beetle range into Connecticut. Revivng a viable population will take an active hand.

10:15 **Southern Pine Beetle Management for Urban Landscapes.** Southern pine beetle (SPB) is killing hard pine species, especially pitch pine. This talk will give an overview of SPB's natural history, identification and impact; the signs and symptoms of infestation and the recommended best management practices for urban and forested landscapes will help arborists, foresters, and land mangers alike advance early detection of, and rapid response to SPB, which is key to suppressing this little, but mighty insects' costly impact while ensuring public safety.
