- 9:15 Seeing the Forest for the Bees. In the historically forested northeastern US, up to 2/3 of our wild bee species use forested habitats for part of their life cycles. Join Kass for an adventure exploring how wild bees use the woods--from the leafy forest floor to deadwood to the "meadow in the sky" at the tippy top of the canopy! She will connect these to applied suggestions, and introduce "focal bees" whose life cycles rely on different characteristic elements of a healthy forest.

- 10:30 Restoration of the American Chestnut. The presentation will review the history of the American chestnut as an important resource from the early eastern forests, from mast for wildlife, food for people and wood for timber and furniture making. Introduction of the chestnut bark blight and its spread throughout the Appalachian Range will be reviewed. Efforts to breed chestnut blight resistance into American chestnut through hybridization with Chinese chestnut and backcrossing will be discussed as well as current efforts with genetic engineering, biocontrol with a hypovirulence virus and improved breeding through recurrent genomic selection.
