**Directions:**

**I-84 from Waterbury** - Take Exit 28, take right onto Rt. 322. Go straight, at 2nd underpass take left at car wash onto Old Turnpike Rd. At first stop sign, take right onto Mulberry Street. Aqua Turf is 1/2 mile on the right.

**I-91 from between New Haven and Hartford** - Take Exit 18, onto I-691 West. Take I-691 to Exit 4. Bear right at end of exit. Proceed to 2nd traffic light, take a right, and go 1 mile to Mulberry Street. Take left, and the Aqua Turf is 1/4 mile on left.
