

BULLETINS LIVE! TWO (BLT) GUIDE



BACKGROUND

WHAT IS BLT?

It is a web-based application that displays geographic areas where pesticide use is restricted to protect a federally listed (endangered/threatened) species or its habitat. These restrictions go beyond what is found in a pesticide label.

MUST I FOLLOW BLT REQUIREMENTS?

Yes. BLT requirements are enforceable. Be sure to print out or save a copy of the bulletin for your pesticide and application area.

WHEN WILL YOU NEED TO CHECK BLT?

Language requiring a user to check BLT can be found in several pesticide labels. When such language appears, often found under "Directions of Use" or "Precautions and Restrictions", you must check BLT and comply with additional pesticide use restrictions, if any.

Users have a six-month window to obtain a bulletin prior to pesticide use. For example, you should obtain a bulletin anywhere between January 1st to July 1st if you plan to apply the pesticide on July 1st.

HOW TO VIEW AND PRINT OUT A BULLETIN

The EPA recommends using Microsoft Edge, Google Chrome, Safari, or Mozilla Firefox to view Bulletins Live! Two (BLT works on any device, but desktop/laptop preferred).

1. Find the EPA Registration Number on your product
 - a. It is commonly found at the bottom or along the margins of pesticide labels.
 - b. If your registration number has two or more parts (for e.g., 10163-21 or 10163-21-123), use the first two parts (for e.g., 10163-21).

4. Enter the geographic location where you would like to apply the pesticide under Location Search.

6. See if a pesticide use limitation area (PULA), denoted by the pink/red colored shape on the map, overlaps your particular application area. If there is an overlap, select the colored shape - a yellow border would now surround the PULA. Click on the "Full Details" button to display the PULA details online.

7. To save a bulletin in PDF format or print a physical copy, ensure your PULA is selected (yellow border appears) or, if there are no PULAs present, zoom in until the "Printable Bulletin" button at the top right corner of the map turns green. Click this button.
