### **DUTIES AND RESPONSIBILITIES**

We are looking for interested persons for the following courses:

Course(s): SANR 425/NRE 4425 Urban and Community Forestry (3 credits)  
SANR 325/NRE 3425 Fundamentals of Arboriculture (3 credits w/Lab)

These course offerings are part of a new program at UConn and will contribute to a new major in Urban Forestry and Arboriculture within the 2-year Associates of Applied Science degree offered through Ratcliffe Hicks School of Agriculture. The course is also open to 4-year students pursuing a Bachelor's of Science degree. The 2-year and 4-year students are taught together, at the same time and place, and all course materials and evaluations will be identical.

### **MINIMUM QUALIFICATIONS**

Bachelor's degree in urban forestry, natural resources, environmental sciences, or a related field; 3-5 years of experience in a related field, featuring urban forest assessment, evaluation, and management.

### **PREFERRED QUALIFICATIONS**

Current or recently retired (past 5 years) urban forester; teaching or training experience; 6-10 years of experience in a related field; excellent oral communication skills. Master's degree in a related field.

### **APPOINTMENT TERMS**

This is a temporary, part-time adjunct faculty position, which is generally appointed on a semester-by-semester basis. Salary will be commensurate with qualifications and experience.
