Electrical Hazards Awareness Program Workshop

The annual English Electrical Hazard Awareness Workshop took place at Eversource Energy on Thursday, November 14, 2024. There were 115 people in attendance for the full day of instruction. The day started off with Doug Pistawka, Eversource, welcoming the group and taking care of house-keeping. Dave Ross, Woodland Tree Works, was the first instructor of the day. He covered EHAP introduction and regulatory aspects and electrical hazards. Next, Doug talked about hardware recognition, utility response protocols and a great demonstration with the Sparkbox. After lunch, Marianne Bonito, Federal OSHA, gave a talk on OSHA statistics within the tree industry. Lastly, Emmett Shutts, Davey Tree Experts, finished the day with safety standards, safe work practices, aerial rescue and emergency response. We thank Eversource Energy for allowing us the use of their auditorium and look forward to returning next year.

The Safety Committee is dedicated to safety education and looks forward to hosting the EHAP workshop in the fall of 2024. The committee meets three times a year. 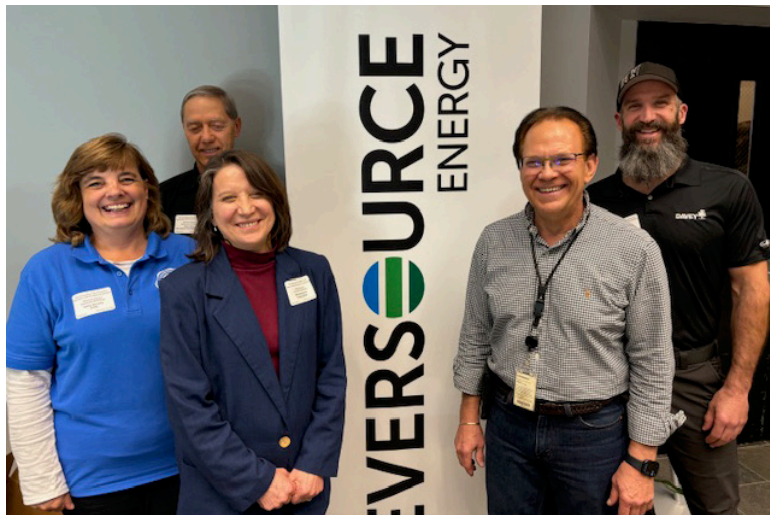

This educational session will run from 9:15 until 10:15.

Trees and the American Experience.

This presentation will be given by historian Eric Rutkow as he draws from his award-winning book *American Canopy* to explore the relationship between Americans and their trees since the nation's founding. The talk looks at several ways that trees have been essential to the early years of the Republic as well as indivisible from the country's subsequent growth and development. Eric Rutkow is an Associate Professor of History at the University of Central Florida. His first book, *American Canopy: Trees, Forests, and the Making of a Nation*, received the Association of American Publishers' PROSE Award for US History, was named one of the top books of the year by Smithsonian magazine, and was selected for Oprah's online book club. He routinely speaks about trees and US history before environmental, academic, and general interest groups, including keynote addresses to the Society of American Foresters and the National Association of State Foresters. He received his BA and PhD from Yale and his JD from Harvard.

This educational session will run from 10:30 to 11:45.

The Three States of Urban Tree Health in Older Trees.

Bill DeVos from Tree Works in Vermont is giving the keynote talk. His focus will be on older trees and considering traditional tree care through a holistic lens, using the three states of urban tree health and his "1st axiom of Arboriculture" to enhance recommendations for a more insightful and effective urban care approach. Bill de Vos is an arborist with over 52 years of professional experience, specializing in Urban Tree Preservation. Based in Vermont, he has worked on projects across 14 states, offering innovative solutions for the care of notable trees. Besides running his company, Treeworks Ltd for 40 years, Bill has had other leadership roles, including past President of New England ISA, Executive Board of ASCA, Vermont Technical College Horticultural Review Board and Chair of the Vermont Urban and Community Forestry Council. Bill has been honored with 11 Excellence in Arboriculture Awards for his distinctive approach to tree care from NAA/TCIA. Bill is a BCMA, RCA, NJ licensed Tree Expert, and Vermont Certified Horticulturist.
